### About Joost Houdijk

### Recent cases

The investigation was completed without any of the organisations involved being indicted. Joost additionally represented a company in the agribusiness sector that was involved in a comprehensive cartel investigation by the ACM. He also assisted Denkavit with its successful acquisition of Nutrifeed from FrieslandCampina.

Joost regularly lectures at universities and private educational institutes, such as the Radboud University of Nijmegen.
